
Exchange Individual Bonds & Rate Reset Preferred Shares to Utilize the Benefits of ETFs and Tax-Loss Harvesting

What is the advantage?

- Investors may be looking to crystallize losses on individual bonds or rate reset preferreds for tax-loss harvesting.
- BMO Exchange Traded Funds (ETFs) has introduced a process in which an investor can convert their individual Canadian bonds or rate reset preferred shares for shares in a corresponding ETF. For example, Canadian short corporate bonds can easily be converted directly into shares of BMO Short Corporate Bond Index ETF (ZCS). This process enables an investor to utilize the benefits of ETFs, while providing standardization, transparency, and diversification, across client accounts.
- Relative to individual bonds and rate reset preferreds, ETFs provide significant benefits to investors. ETFs provide the ability
 to achieve instant diversification through a single trade. As well, ETFs provide significant liquidity benefits for investors that
 are looking to manage a specific allocation or model across several client accounts. ETFs, at worst, will trade at bid-offer
 spreads that are equal to the underlying fixed income bonds or rate reset preferreds, but generally trade at significantly
 tighter spreads, due to the secondary liquidity that is available on the exchange. ETFs provide investors with a costefficient, diversified, and scalable solution for fixed income and preferreds.




